

What You Need to Know When Contacting an Attorney on Our Referral List

The attorneys on this list represent injured workers in Workers Compensation cases in Pennsylvania and /or New Jersey, or in Third Party law suits. Some also handle other areas of law, like employment issues, social security disability and auto accidents. Their areas of practice are listed under their firms name.

You must discuss and reach an agreement with your attorney on any fee arrangements before signing a written agreement with them. Always be sure to carefully read an agreement before signing it.

In Pennsylvania the suggested ceiling for fees in workers' compensation cases is 20%. If you receive a lump sum settlement of your claim, the attorney's fee is negotiable. In New Jersey, fees may be set by NJ workers compensation court.

All of these attorneys have also agreed to the following:

- To consult by phone or in person with Philaposh referrals at no charge;
- In cases where a brief letter is all that is required to assist an injured worker in obtaining compensation, there will be no charge;

Attorney fees in third party or product liability law suits are different than workers' compensation fees and must be discussed with your attorney.
